Ms. Lund shared the naming rights list from the Kenneth J. Smith Instructional Building renovation project, which was part of the Transforming Lives, Empowering People major gifts campaign and asked for Board approval.

Upon motion duly made by Stump and supported by Deuling-Ravell, the following resolution was unanimously approved:

BE IT RESOLVED, That the naming rights of the Kenneth J. Smith Instructional Building renovation project is approved.

Mrs. Carbonelli appointed Ms. Stewart Assistant Treasurer to the Board of Trustees.

The Trustees appointed Dr. Bradley Barrick Montcalm Community College's 2024-25 President Director, Trustee Carol Deuling-Ravell MCC's 2024-25 Trustee Director and Trustee Karen Carbonelli MCC's 2024-25 Alternate Trustee Director to the Michigan Community College Association Board of Directors.

Ms. Stewart gave a faculty negotiation update. She said they are not there yet but should be wrapping up this week.

Upon motion duly made by Kitchenmaster and supported by Stump, the following resolution was unanimously approved:

BE IT RESOLVED, That the contract for Montcalm Community College Vice President for Academic Affairs Steven Fosgard for 7/1/24 through 6/30/26 and contract for MCC's Senior Vice President and Chief Operating Officer Connie Stewart for 7/1/24 through 6/30/26 is approved.

Upon motion duly made by Marston and supported by Kitchenmaster, the following resolution was unanimously approved:

BE IT RESOLVED, That Montcalm Community College enters into the application phase of securing funding for the student housing project with the U.S. Department of Agriculture/Rural Development and continue with the design, engineering, and construction phases, with a completion date of summer/fall 2026.

At 9:46 a.m., Deuling-Ravell moved that the meeting adjourn. Peterson supported the motion, which carried unanimously.
